ROGER WILKINS ELECTED CHAIRMAN OF BROADCAST-PLAZA, INCORPORATED

The election of Roger C. Wilkins as chairman of Broad-cast-Plaza, Inc. was announced January 23 following a meeting of the corporation's board of directors.

He succeeds Gladden W. Baker, who has retired.

The board also announced the election of Richard M. Page as a director and secretary and Chester S. Keffer as assistant treasurer and assistant secretary. Broadcast-Plaza, Inc. owns and operates Constitution Plaza and WTIC TV-AM-FM.

Mr. Wilkins, senior vice president of the Travelers Insurance Co., has been with the Travelers since 1929. In 1953, he was named vice president of the Company. He became senior vice president in 1965.

Mr. Wilkins played an important role in the development of Constitution Plaza, serving as president and general manager of Constitution Plaza, Inc. from 1960 to 1964. He became vice chairman of Broadcast-Plaza, Inc. after the corporation was formed through the merger of Constitution Plaza, Inc. and the Travelers Broadcasting Service Corp.

Active in civic affairs, Mr. Wilkins is a former chairman of the committee for Hartford, former vice president of the Greater Hartford Chamber of Commerce and present chairman of its Housing Committee. He is president of the Institute of Living, a trustee of the State Savings Bank, Wadsworth Atheneum and the American Institute of Architects Foundation.

Mr. Baker, who retired in 1964 as a director and chairman of the finance committee of the Travelers Insurance Co., also played a major role in the creation of Constitution Plaza. He joined the Travelers in 1926 and became vice president and treasurer in 1941. In 1945 he was elected a Travelers director and in 1955, he became chairman of the Travelers finance committee. Long active in community affairs, Mr. Baker was a leader in Hartford's efforts to redevelop the downtown area and served for many years as chairman of the Urban Redevelopment Committee of the Greater Hartford Chamber of Commerce.

Mr. Page joined the Travelers as an associate in the law department in 1959 and was named an attorney in 196 He received his A.B. degree from Dartmouth College and his LL.B. from Columbia Law School.

He is president of the Dartmouth Club of Hartford, chairman of the Wethersfield Republican Town Committee and the Businessmen's and Civic Associations of Wether
