

### TELEVISION TOURS PLANNED ON PEOPLE, PLACES SERIES

Hospital patients, the elderly and other shut-ins will be invited to select places and people in Southern New England to be visited --via television in a new WTIC-TV series of programs currently being planned for the 1969-70 season.

The new series, tentatively titled "Places and People," was announced July 21 by President Patricelli.

Mr. Patricelli said patients in hospitals and convalescent homes, members of senior citizen groups and others confined to their homes or hospitals will be invited to sub-

is suggestions of places they would like to visit and people they would enjoy meeting through television.

"Some programs will be devoted entirely to a person or place selected by our audience," Mr. Patricelli said, "while others will include brief visits to several locations or several people. In general, we will try to visit one interesting place and one equally interesting person on each program.

"We plan to add a new dimension to the usual television documentary series by providing more for the television audience to see than an (Continued on Page 2)

### STATIONS WILL DROP ALL CIGARETTE ADVERTISING

WTIC-TV and Radio have announced plans to drop all cigarette advertising.

President Patricelli announced that no new cigarette advertising will be accepted after July 24 and all locally purchased and originated cigarette commercials now under contract will be deleted from Channel 3 and WTIC AM and FM by Aug. 31. He said negotiations are being conducted with the Columbia Broadcasting System and the National Broadcasting Co. in order to arrange a termination date for network commercials currently broadcast on the stations. WTIC-TV is affiliated with CBS and WTIC AM and FM are NBC affiliates.

'We are seeking the earliest possible date for the termination of network commercials, while taking into consideration the contractual commitments the two networks have with cigarette advertisers," Mr. Patricelli said. "The date of the last network cigarette commercial to be broadcast on our stations will be announced as soon as these negotiations are completed."

#### EDITORIAL URGED FLYING FLAGS FOR APOLLO RETURN

Flags flew in many places on the day the moon voyagers returned to earth as the result of a suggestion made in a WTIC-TV and Radio editorial.

The editorial, by President Patricelli, appears on Page 2. It inspired the National Association of Broadcasters to request all stations in the nation to urge their listeners and viewers to fly the flag on July  $2^4$ .

"Such a gesture," said the NAB, "would symbolize the pride of Americans in the victory for all mankind achieved through our space program."

#### THREE MORE DEER PRESENTED TO ZOO

#### RELIGIOUS DRAMA AWARDS ANNOUNCED

Winners of a television drama competition sponsored by the Cooperative Broadcast Ministry of Connecticut and WTIC-TV were announced July 18 by the sponsors.

"The Bridge," a drama by Richard N. Young of Montclair, N.J. received the first prize of \$200. Second prize of \$100 was won by Marion E. Timm Jones of Meriden for a play entitled, "You Gonna Be the Death of Me, Yet" and honorable mention went to Ann Scharin of West Hartford for "Escalation to Eternity."

All three plays will be produced next season by WTIC-TV.

The competition was sponsored by the station and the Cooperative Broadcast Ministry to encourage creative writing talent and supply dramatic material illustrating themes and issues of concern to the contemporary church. The Cooperative Broadcast Ministry is the broadcasting unit of the Greater Hartford and Connecticut Councils of Churches and also includes the Communications Office of the Roman Catholic Archdiocese of Hartford.

The judges were: Ivor Hugh, director of the Communications Department of the Greater Hartford Council of Churches and the Cooperative Broadcast Ministry; Edgar L. Kloten of the Speech and Drama Department, University of Hartford; Harrison Parcell, WTIC-TV production manager, and John Sibun, a play and television director for several community theatre groups in the Greater Hartford area.

#### BPI MAKES CONTRIBUTIONS TO EDUCATIONAL BROADCASTERS

Broadcast-Plaza, Inc. has made domations of equipment and spacesharing to several educational broadcasting stations in the state.

Short-wave equipment recently removed from both the News Car and the base station at Avon, which comprises the other terminal of this facility, were given to Wesleyan University for similar purposes at station WESU (FM).

The Connecticut Educational Television Corp. has been given permission to share space in our microwave relay station KCN-82 building at Prospect, Conn. where they will operate a relay connecting WEDH, Hartford and WEDW, Bridgeport. The Hartford end of the circuit will be at the WTIC transmitter in Avon which already houses the WEDH (TV) transmitter operated by WTIC Staff members.

A new educational station to be located in New Haven and which will cerate on Channel 65 has been ven permission to locate a relay station at our property in Tolland, Conn. This is where our relay stations KCH=84 and KIK-81 are located. The new station will carry programs of the Eastern Education Network from Boston to New Haven through an intermediate relay near Meriden.

These gifts typify Broadcast-Plaza's policy of encouraging noncommerical educational broadcasting.

#### APOLLO INTERVIEWS AT MYSTIC

WTIC-TV contributed to the CBS overage of the flight of Apollo II yy providing man-in-the-street interviews with visitors to Mystic Seaport, a memorial to the adventurous spirit of earlier Americans.

Feeds were provided to the network on the day the Eagle landed on the 'moon and on the morning after the first walk by Astronauts Armstrong and Aldrin. Interviews were con-

ted by Lou Palmer and Bill Haskell. Dick Huntley was the producer; Don Moore, the director, and Fred Edwards, the engineering supervisor.

and disruptions led by the Students for a Democratic Society and aimed at job interviews conducted by defense contractors, the armed forces and government agencies. The program tried to clarify a confusing situation by presenting a factual report that gave all sides an opportunity to be heard. It sought to determine what the demonstrators wanted and why they tried to disrupt campus activities to achieve their goals and also tried to get the reaction of other student and faculty members who were not involved in the disruptions.

In addition, the program gave the president of the university, Dr. Homer Babbidge, an opportunity to reply to criticism that was coming from both left and right.

The RTNDA regional award cites WTIC-TV for its "indepth coverage of presenting problems of the conflicting rights of dissident and university community groups." The WTIC-TV documentary and a series produced by WCAU-TV, Philadelphia, will compete with programs produced by stations in other sections of the nation for a national award to be presented in September.

"UConn - What's This All About?" also received a special citation from United Press International.

The program was produced by George Bowe. Larrye deBear was the reporter; Jim Aseltine the director, and Allen Allshouse, the film editor. The audio technicians were Mickey Gentile and Randy Scalise and the lighting technician was Alistair MacDonald. The cameramen were Herman Heinze, Robert Dwyer, Lynn Boscher, Dennis Switaj, Wayne Wood and Robert Butterworth.
